Town Board Regular Meeting held June 26, 2025 at the Town Hall at 6:00 p.m.

Present: Chairman Larry Reas, Clerk Angela Sales, Crew Representative Donny Weinberger, and 3 electors. Supervisor Mark Donner and Supervisor Sue Schemberger were in attendance via zoom.

The meeting was called to order by Chairman Reas at 6:00 p.m.

- 1. Public Comment: None.
- 2. Minutes of June 12, 2025 meeting, review and approve. Supervisor Donner made a motion to approve the minutes as presented, Supervisor Schemberger seconded the motion, motion passed-unanimously by roll call vote.

- b. Supervisor Donner made a motion that we hire someone to mow the grass at the Town Hall/ Garage/Transfer Station while we are looking for a used mower (regular lawn tractor). Supervisor Schemberger seconded the motion, motion passed- unanimously by roll call vote.
- 6. Road Work Report: Crew representative Weinberger reported that the crew has been working on ditching on Hilltop Road. They have also been working on the #5 dump truck, which is almost done. They are waiting for a bracket for the wing and then it should be ready for painting. One of the next projects will be E. Mader Road: sinking culvert and cold mix blacktop repairs.
