Town Board Regular Meeting held July 10, 2025 at the Town Hall at 6:00 p.m.

Present: Chairman Larry Reas, Supervisor Mark Donner, Supervisor Sue Schemberger, Treasurer Judy Reas, Clerk Angela Sales, Crew Supervisor Tim Schloer, and 0 electors

The meeting was called to order by Chairman Reas at 6:00 p.m.

- 1. Public Comment: None.
- 2. Minutes of June 26, 2025 meeting, review and approve. Supervisor Donner made a motion to approve the minutes as presented, Supervisor Schemberger seconded the motion, motion passed-unanimously.
- 3. Vouchers, review and approve/deny. Checks 27833-27877 in the total amount of \$46,953.47 were reviewed. Supervisor Schemberger made a motion to approve the vouchers, Supervisor Donner seconded the motion, motion passed-unanimously.

4. Chairman's Report.

- a. Driveway Access/Fireworks/Picnic/Overweight Permit updates: None.
- b. Five-Year Road Plan: 2025 Chip Sealing. Supervisor Donner made a motion that we post for bids for the 2025 completion of chip sealing four sections of road, totaling approximately 4 miles. Motion seconded by Supervisor Schemberger and motion passed-unanimously.

4. Unfinished Business.

- a. Kaiser/Town of Lake Foundation: Supervisor Donner made a motion to approve the document as submitted and to appoint Chairman Larry Reas, Supervisor Sue Schemberger, and Supervisor Mark Donner as the foundation committee, with Clerk Angela Sales appointed as the designee to administer the account. The authorized signers for the account shall be the foundation committee members and clerk, as well as Treasurer Judy Reas. The foundation committee shall meet annually, during a regular scheduled Town Board Meeting. This motion was seconded by Supervisor Schemberger and motion passed-unanimously.
- b. Rural Energy Grant: Clerk provided updates.
- 5. New Business. Discussed www.enjoypricecounty.com website link being added to our town website.
- 6. Road Work Report: Crew supervisor Schloer reported that #5 dump truck is about 2 days from being done in the shop-hydraulic hoses are being worked on. Painting to tentatively begin next week with about a 2-week turn around time. Ditching continues on Hilltop Road. 30" Culvert at end of Kaiser Road needs to be worked on. Mowing of ditches should be taking place soon-maybe next week. Cold patch repairs taking place on Helberg and Schloer Roads. We will need to look at purchasing a used mower next year or hiring someone to mow the grassy areas by the Town Hall Buildings and Transfer Station. Discussed putting up a gate by the brush pile area so that the Transfer Station Attendant(s) would have to be present for residents to access this area, due to furniture and other items being left there.
